Matters arising from meeting held on Monday 25th Feb25

- a) **26July23/202 Tiny Tree Farm** - Ongoing
- b) **11/24 Lock at Cyd Terrace** - No further updates at present.
- c) **16/24 The Ganu** - Communication is currently ongoing .Council are awaiting an email from the trustees to finalise the decision made
- d) **38/24 Hill Street Park** - Access to the park safe at present. The issues with dogs fouling in the park have now hopefully been resolved. New baby swings have also been installed
- e) **50/24 Dog Bin, Cyd Terrace** - A map has now been drawn for all bins within our ward. Cllr Hadley is currently working with Cllr Lewis in the best places for the bins to be evenly distributed throughout the villages.
- f) **51/24 Council Community Surgery** - The next Council Community Surgery will be held on Wed 16th April, at Clyne Community Centre, between 12p.m until 2p.m
- g) **45/24 Update on Bryn Golwg Park** - We are currently awaiting confirmation on the success of the grant . Cllr Lucy Hadley to update

h) 1/25 Old Melincourt Park Site - Plans are now being put in place to return this land to a usable condition. Over the coming months work will begin to clear the debris and treat the overgrowth. This is the beginning of a lengthy project and we appreciate your patience and support. Quotes to clear the knotweed have been received. Councillors discussed the quotes in detail. Cllr Coslett proposed that we accepted the quote, seconded by Cllr Lucy Hadley. Quote accepted with a unanimous vote (1a/25)

i) 2/25 Food Poverty Grant - Cllr Hadley and Cllr Coslett were successful in acquiring a grant that allowed us to update appliances in our kitchen at Clyne Community Centre, along with tables, games and activities for community use. Cllr Golding, Cllr Lucy Hadley, Lynfa Hadley and with help from their family, transformed the kitchen and store room into more organised and functional rooms for future use. The council would like to thank them all for their efforts

j) 3/25 Letter received from Friends of Clyne & Melincourt

A letter has been received from the group in regards to confrontation between the group members and Cllr Kerrison. They have asked that Cllr Kerrison is not directly involved in any correspondence with the group and that he no longer opens/closes the Community Centre for any future events. This has been discussed by the Council as a whole. The council has discussed this issue with Cllr Kerrison, stating that his behaviour is unacceptable going forward and goes against our Code of Conduct/ safeguarding policy. Mr Kerrison will not be the key holder for any future events with this group
